The main goal of Fairbanks Youth Advocates is to provide support to homeless youth. We operate The Door, a 24-7 emergency shelter for youth ages 12 through 18. Operation of the shelter includes a multitude of services, one very important part is the providing of healthy meals to youth who walk through our doors.
