Greetings, Member-Owners of Fairbanks Co-op Market Grocery & Deli.

We are writing on behalf of Fairbanks Open Radio to request your generous donations through the Lend-A-Hand Register Roundup. Fairbanks Open Radio operates the only 100% community-sponsored, educational radio station in Alaska. We established our 501(c)(3) nonprofit corporation in 2014 “to bring independent, noncommercial, educational radio to Interior Alaska.” Since broadcasting the Fairbanks Winter Folk Fest live in February 2016, our all-volunteer organization has been producing and syndicating progressive programming 24 hours a day, 7 days a week via our LPFM radio station - KWRK-LP 90.9 FM - and now also via our [Internet live stream](#).

Several of us at KWRK are member-owners who were active in making the Co-op a reality, and our mission is quite compatible with Co-op Market’s, particularly our endeavor “to educate and mobilize our community” “for social and environmental justice” and “for local economy and fair, transparent trade”. Some of the shows that we proudly syndicate towards those ends include:

- [“Food Sleuth Radio”](#), a “green food radio show” hosted by Melinda Hemmelgarn, a registered dietitian and “investigative nutritionist” who interviews national experts in food, health, and agriculture;
- [“Your Own Health and Fitness”](#), on the politics and practice of health and the environment;
- [“Economic Update”](#), an educational economics show hosted by Professor Richard Wolff that champions cooperatives and other alternatives to multinational corporate capitalism;
- [“Radio Ecoshock”](#), covering the latest on climate disruption, including interviews with top scientists, authors and activists.

We also boast several locally produced shows and are recruiting for more to cover such subjects as local food production and sustainability. Discover more about the valuable community resource that is Fairbanks Open Radio at [KWRK.org](#), where you can also find our [broadcast schedule](#).

Fairbanks Open Radio has no paid staff, so every penny donated goes directly towards our operating costs. Above and beyond being a nonprofit, our membership is committed to avoiding the pitfalls of censorship that so often befall those media outlets who do not vet their sources of financial support. The no-frills approach to our operations keeps our costs low, such that we are accessible to our fellow workers and not dependent on the benevolence of oligarchs.
