Fairbanks Youth Advocates believes that providing emergency shelter at critical times in the lives of young people is vital to their present and future well being, ultimately contributing to the stability and long term health of our community.

Fairbanks Youth Advocates' main goal is to provide support to homeless youth. We operate The Door, a 24-7 emergency shelter for youth ages 12 through 18. We provide safe shelter, three meals a day and two snacks. We provide support and connections to community resources as well as mediation and reconciliation support.
